Payment plans will only be offered with an automatic withdrawal via credit card. Please initial below if you want the payment plan. A \$25 service fee will be charged for declined payments. A \$25 processing fee will be charged for refunds after the registration deadline dates. All camp programs must be paid in full at the time of registration if not using the payment plan. All camp participants are required to fill out a Camper Information Packet prior to the start of Camp. Completed Camper Information Packets are due the day of registration. Any campers who do not have a completed packet including a current picture prior to the start of camp will be charged a \$10 service fee. Camper Information Packets are available at rmparks.org or at the Community Center front counter.

Payment dates for the auto-withdrawal plan:

1st payment increment is due the day of registration.

Remaining payments occur on the 1st of every month leading up to 6/1, and 7/1 if registered for all camp sessions.

Payment plans for session 1 must be completed on 6/1. Payment plans for session 2 must be completed on 7/1.
